- Research and interpret tax laws and regulations to provide expert advice to clients and internal stakeholders.
- Develop and implement tax planning strategies to minimize tax liabilities for clients.
- Maintain up-to-date knowledge of changes in tax laws and regulations and communicate their implications to clients and team members.
- Utilize tax preparation software proficiently to streamline the tax preparation process and ensure efficiency.
- Collaborate with clients and internal teams to gather necessary information and documentation for tax filings.
- Communicate effectively with clients, tax authorities, and other stakeholders to address inquiries and resolve issues related to tax matters.
